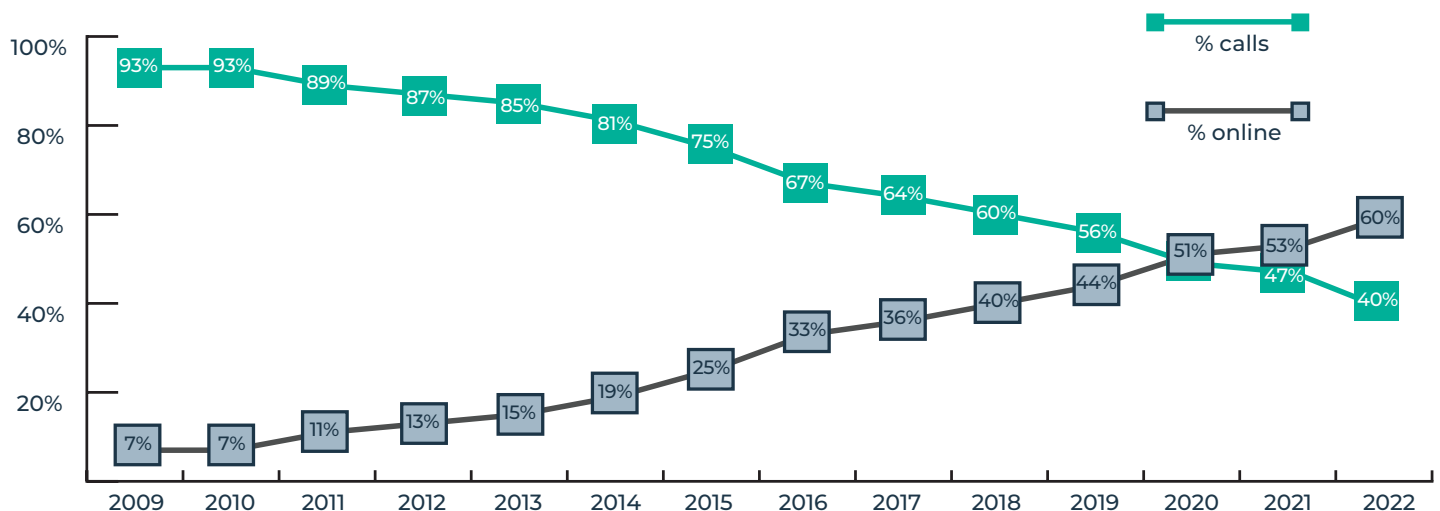

# Projects & Campaigns

**Bikelinc** has over 50,000 bikes, with an estimated value of \$72 million, listed on its free, secure platform. Over 75 stolen bikes have been returned to their rightful owners, either by police or direct community intervention. Bikelinc won an Australian Crime and Violence Prevention Silver Award from the Australian Institute of Criminology and a Crime Stoppers International Specialised Program Award. **Safe2Say** is an anonymous integrity reporting platform, with a unique two-way anonymous chat function, for enhancing your organisation's culture, reputation and employee well-being. Recommended in the report *Enough is Enough: Sexual harassment against women in the FIFO industry*, it was also a finalist in two 2022 Work Health & Safety Excellence Awards and listed in the Australian Human Rights Commission Respect@Work website. **GovConnect** is only licensed to government agencies who have an enforcement and intelligence gathering function. Five agencies now use the Crime Stoppers WA anonymous platform, with customised forms, to receive reports directly - Corrective Services, WA ScamNet, Dept of Water & Environmental Regulation, Small Business Development Corporation and Dept of Primary Industries & Regional Development for FishWatch and AgWatch.



**Eyes on the Street** was initially developed for industry personnel (security guards, shire rangers, taxi & ride share drivers, couriers or hotel staff) to report suspicious activity. This is now more widely used across local government organisations and communities and promoted by Neighbourhood Watch groups.



**Civics & Citizenship Teachers Resource** has a new theme pack Wildlife Crime & the Law added to its award-winning package. The 7 module package is endorsed by Education Services Australia and listed on Scootle, the national repository which provides schools with digital resources aligned to the Australian Curriculum. **No Illegal Guns** was Phase 2 of the National Illegal Firearms Campaign. It encouraged people to 'say something before it's too late' and report what they know about illegal guns, and safely surrender any they might have. In WA, to the end of Dec 2022, 3,280 firearms were handed in or relinquished and 81,541 rounds of ammunition. Click [here](#) to read more.



**Make The Right Call** was a national campaign to educate the community about what number to call and when to contact Crime Stoppers versus the police. Use 000 for emergencies, 131 444 for police assistance and 1800 333 000 to share information. This was to address the ongoing issue with police and emergency services receiving incorrect calls and people contacting Crime Stoppers and expecting immediate police assistance.



**CaLD Community Engagement** involved videos in Mandarin and Cantonese being developed with Neighbourhood Watch Asian Community Services to help Chinese communities understand Crime Stoppers and how and when to make the right call. Our Ethical Leadership Program, run in partnership with Edith Cowan University and Edmund Rice Centre of WA, won a 2022 Crime Stoppers International Specialised Training Award for young and emerging leaders in CaLD communities.
